### **PLEASE NOTE: VEHICLE USE PERMIT REQUIRED**

Either a WDFW vehicle access pass or Discover Pass is required to be displayed in the vehicle of anyone participating in this event. Purchase permits at retail locations where hunting/fishing licenses are available, or online at <https://fishhunt.dfw.wa.gov/wdfw/vup.html>

Or you may choose to purchase a Discover Pass. The Discover Pass must be displayed on your vehicle when visiting state recreation lands managed by the Washington State Parks and Recreation Commission, the Washington State Department of Natural Resources and the Washington Department of Fish and Wildlife. The fine for not displaying the pass is \$99.
