WWESSC will have blaze orange vests available for guests to borrow.

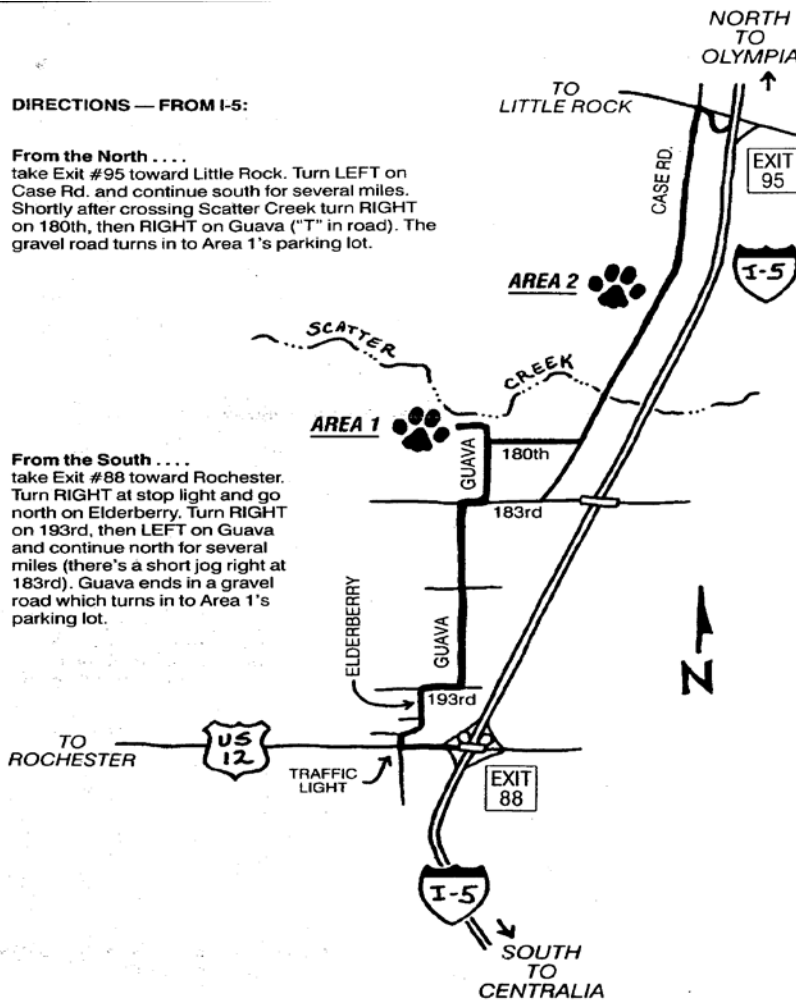
Smoking is not allowed while in the field. Smoking is permitted in the parking area.
