EVENT EMERGENCY AND VETERINARIAN INFORMATION

In accordance with an "Amendment in the Standard Procedures for Spaniel Field Trials" effective September 1, 1994 a blaze orange garment or item of clothing is mandatory at all AKC licensed and sanctioned field trials for ALL persons in the gallery and in the field.

NO ATV's will be allowed on the field except those used by the committee for bird planters or movemnet of judges. Request to use personal ATV's must be made to the chariman prior to entering the field. ALL ATV'S MUST HAVE AN ORANGE FLAG which can be seen by the gunners in the field.

Consistent with AKC regulations, the use of prong collars is prohibited on the trial grounds. This regulation will be strictly enforced.

Sever training, correcting or disciplining of dogs will not be allowed on any part of the grounds.
