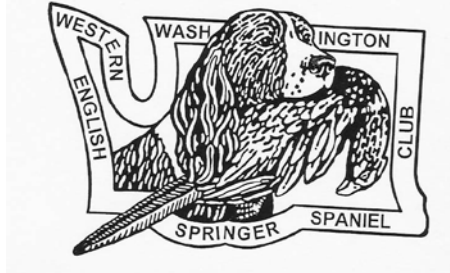

**\*\*ENTRY OPTIONS\*\***

There are two options for submitting and payment for entries.

1. If making payment by **check**:

  - b. I will send you an invoice from PayPal that can be paid through your PayPal account or by credit card. **Each** Open and Amateur entry will be charged an additional \$3.75 PayPal fee. Each Puppy entry will be charged a \$1.00 fee. Entries must be paid for before the draw (October 14 at 8:00 pm).
