We have secured a vast amount of challenging hunting cover, quality birds and experienced guns. All we need are your quality spaniels. The grounds are located near Sterling, CO. Please take a break and come to colorful Colorado for our annual fall trial.

Trial Judges: 1st Trial: Clay Earl (ON) & Randy Manore (MN) 2nd Trial: Russ Smith (OH) & Brud Prock (IL)

Trial Grounds: The 1^{st} Trial Grounds will be at Tamarack Ranch SWA which is located 25 miles from Sterling. The 2^{nd} Trial Grounds will be held at the Kues Farm near Fleming, CO which is 10 miles from the 1^{st} grounds.

Schedule of Events: Please read! Early Start Times on Friday & Saturday. Alternating series for the second trial only!

First trial: Friday, September 29th and Saturday Sept 30th. Tamarack Ranch State Wildlife Area. Start time Friday 7:30 AM. Open run to conclusion on Friday. Puppy between 2nd and 3rd series of open. Not before 11:00 AM. First series of Amateur to start at conclusion of the open Friday Sept 29 not before 1:00 PM. 2nd and 3rd series will be held Sat Sept 30th start time 7:30 AM at Tamarack Ranch SWA.

Second Trial: Saturday Sept 30th and Oct. 1st. Kues Farm, Fleming, CO. Start Time: Open all age at conclusion of first trial, Not before 1:00PM Saturday, Sept 30th. Amateur starts following the completion of first series of open on Saturday Sept 30th then stakes will be alternating thereafter. Second and third series will be held on Oct 1st. Start time 7:30 AM Sunday Oct 1st. NO puppy stake for this trial. Pheasant and/or chukar for all ages, Pigeon and/or Chukars for Puppies.

Cocktail Party: Will be held on Saturday, September 30th immediately following the day of trialing. Complimentary Beer, Wine and Hors d'oeuvrves will be served. Placements for the first trail and call backs for the second trial will be announced at the party.

Lunches: There will be hot lunches available on the grounds for sale each day. The price is \$5 per lunch. We will also have assorted drinks and snacks available for a modest cost.

Headquarters: The headquarters for the trials will be at the Ramada Inn, Sterling, CO at exit 125 on I-76, 22140 East Hwy 6, Sterling CO, 80751, Phone: 970-522-2625. The hotel is 25 miles from the trial grounds. There is a room block under the Pawnee Flushing Spaniel Club and the price is \$85 per night for double bed room, plus taxes. **Please reserve your room by August 31st to hold the rate**. The Sterling area is very busy that time of year so please reserve your room ahead of time. There is also dry RV parking at the main entrance to the grounds. If planning on camping at the grounds entrance, please do not air your dogs in the camping area.
