### DIRECTIONS TO TRIAL GROUNDS

From Terrace Bay Hotel, Escanaba, take P Road to Highway US2&41&M35 North for 2.5 miles to 1st traffic light in Gladstone. Prepare to turn left at 2nd traffic light onto M35 North. Continue 10 miles on M35 North to Perkins. Left at the 3-way stop for 8.5 miles to Rock. 1 mile north of the blinking yellow light in Rock, turn right onto N. Rock 38th Road. Continue through 1<sup>st</sup> curve to the left to 2<sup>nd</sup> curve to the right. The driveway to North Rock Hie On Acres is on the left side of 2nd curve.
