#### **BIRDS**

PHEASANTS FOR OPEN AND AMATEUR STAKES, PIGEONS FOR PUPPY STAKE

#### **CONDITIONS FOR ENTRIES:**

**Puppies:** Any AKC registered English Springer Spaniel that has not reached its second birthday on the first day of the trial.

**Amateur All Age:** For any Amateur handler and any AKC registered English Springer Spaniel over six months of age.

**Open All Age:** For any AKC registered Springer Spaniel over six months of age.

#### **Note:**

- A separate entry form must be submitted for each dog entered and for each Stake entered.
- Training on Field Trial Grounds on the days of the events or the day prior is not allowed.
- Smoking is allowed **only** in the parking area *not* in the field.
- Bitches in heat are prohibited on the grounds.
- Any and all dogs must be kept on leash until called to the line.

Please cooperate with the Marshall, Judges and Field Trial Committee.

***Blaze Orange is required to be worn and visible above the waist by participants and observers.***
