Please do not applaud. Applause or unnecessary noise may interfere with

the handler and his or her dog. Please be as quiet as possible while the dogs are working, as this Field Trial awards Championship Points.

Dogs not competing must positively be kept off the grounds. All dogs must be on a leash when not running in a stake.

Any spectators who would like training information, or who are interested in English Springer Spaniels, we extend an invitation to discuss your questions with a Club Member.

Please cooperate by staying behind the Field Marshal.
