**Directions**

Traveling on I-99, 6 miles north of Altoona, take the Bellwood exit #41 (Rt. 865).

- At exit ramp stop sign, turn right toward town of Skelp and drive over Skelp Mountain for approx. 3.6 miles.
- At the stop sign in the small town of Skelp, turn right onto Golf Course Road.
- Go 0.5 mile to stop sign.
- At this point, look for trial flags / signs pointing to the fields.
