DIRECTIONS TO GROUNDS FROM FIELD TRIAL HEADQUARTERS:

Mapquest directions to grounds from Super 8 in Alexandria, MN (trial headquarters):

Takes 35-40 minutes to get to the grounds.

Start out going south on Frontage Road toward 48th Avenue Turn slight right onto MN 29 Merge onto I-94 W/US-52 Go about 13 miles Take Exit 90 toward Brandon Turn right on County Road 7 Go about ¹/₄ mile Turn slight right onto Central Avenue Go about .85 miles Central Avenue turns into County Road 7 Go about 10 miles County Road 7 becomes County Highway 87 Go about 1 mile Turn left onto County Highway 38 Go about 2.75 miles Turn right onto County Highway 5 Go about 3.75 miles

Look for signs to get you on the gravel road to the grounds. A map is provided on essft.com as well. Address to farm is GPS friendly.
