These are private grounds which are being maintained under the Willamette Valley Wet Prairie initiative. We ask that all participants and visitors take care to follow all signage with regards to off limits areas. **Please do not park off the roads.**

Our Amateur and Puppy Stakes will be Saturday, October 6th and the Open Stake Sunday, October 7th. **Entries close on September 26, 2018.**

Judges: This year we are very pleased to have Kathy Nestor from Michigan and Jerry Livingston from Idaho as our judges for the Open and Amateur Stakes. Puppy Stake judges are David Anderson and Gary Davis, both from Oregon.

Please RSVP with the Field Trial Secretary when entering as we need an accurate count for the restaurant. Awards for the Open will be presented on the grounds Sunday after the end of the trial.

To Grounds from I5:

In Salem take exit 253.

Head West on Mission St. (Hwy 22).

Continue west through Salem and follow the signs for Hwy 22.

Staying on Hwy 22, cross the Mission St. Bridge and continue West towards the coast.

After about 9.5 miles take exit 16 (99W).

Proceed North on Hwy 99W towards McMinnville for 2.4 miles.

Look for the NWESSC sign and turn right (east) onto Farmer Road.

Drive east .5 mile and turn right (south) at the double flags.

Proceed to the top of the hill to park. Do not park in the shed at the top of the hill as that area will serve as our headquarters. **Please do not park off the roads.**

To Grounds from Headquarters:

Head south on OR-99W S/Nindels

Continue approximately 15.9 miles

Look for the NWESSC sign and turn left (east) onto Farmer Road.

Drive east .5 mile and turn right (south) at the double flags.

Proceed to the top of the hill to park. Do not park in the shed at the top of the hill as that area will serve as our headquarters. **Please do not park off the roads.**
