Emergency Contacts: Emergency contacts, per AKC regulations, will be posted on the grounds and listed in the catalog. There will be cellular phones available in case of an emergency

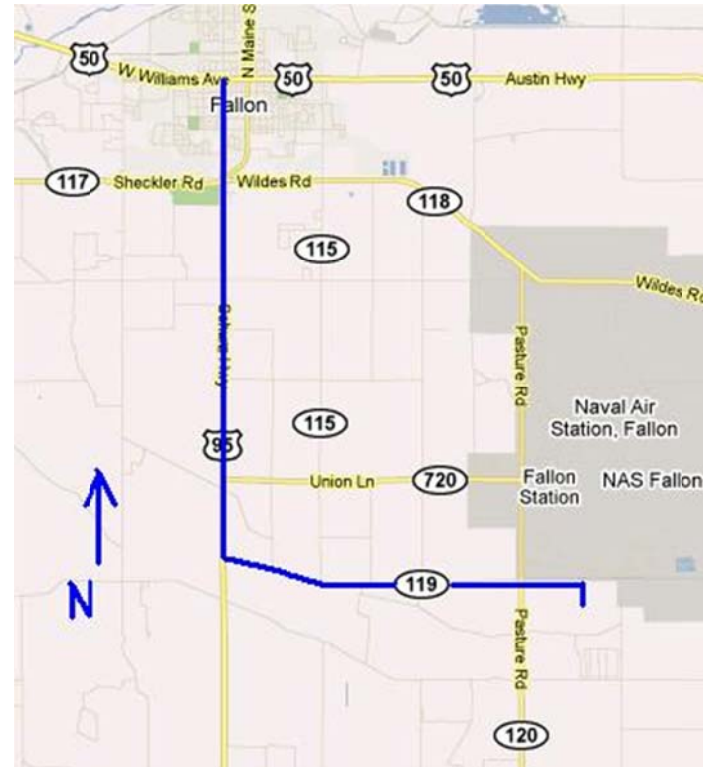
Training Day: The grounds will be available on Friday, for training at 2:00 PM: Pheasants will be available for \$11.00 each. Please indicate quantity on reservation form.
