Dear Field Trialers:

The Rocky Mountain Springer Spaniel Association cordially invites you to our annual fall field trial. This year we are holding our trial on Thursday October 4th and Friday October 5th, in conjunction with the Northern Colorado Springer Spaniel Club the following weekend. The trial grounds are located north of WCR 14 and east of WCR 37 on the Miller property. The cover is a mixture of grass and weeds.

Our All Age judges are Rob Barlow and Charlie Petrmichl. The Open Stake will begin At 8:00 am on Thursday and the Amateur Stake will be at 8:00 am on Friday. The Puppy Stake will begin no sooner than the end of the second series of the Open Stake on Thursday. We will not have a formal training session before the trial. Our Puppy judges will be announced before the trial.

The trial headquarters have changed this year due to a new hotel located 5 miles from the trial grounds. 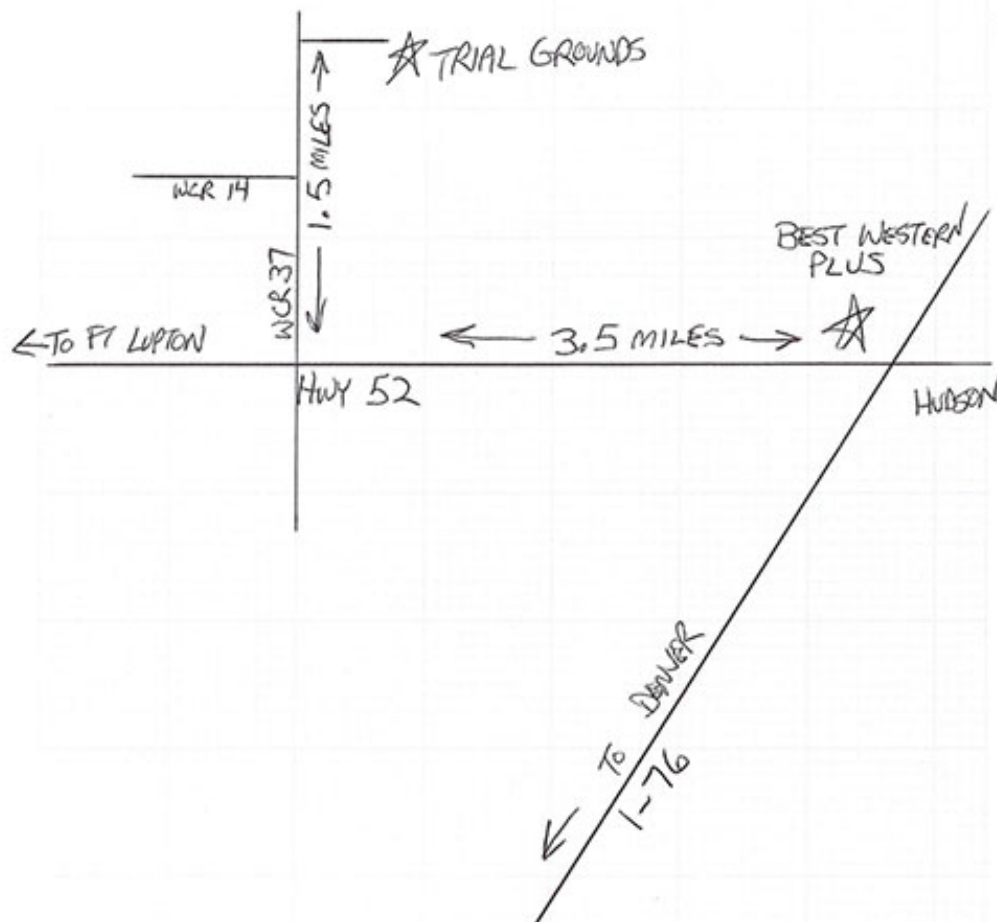
