Be prepared to provide water for your dog while in the field. Please remember all participants and spectators must wear **Blaze Orange Clothing** into the field.

Smoking will not be allowed in the field.

2. After passing the courthouse square, go left on 22nd Street (IL-16).
3. Go left on 22nd Street (IL-16) for about 1.2 miles
4. Go left on Broadway.
5. After two blocks, go left at the T in the road, this becomes Lakecrest Trail as it crosses the railroad tracks.
6. Lakecrest Trail will curve to the right, then 1000 feet later will curve to the left.
7. Turn right on Lakecrest Lane, CrannieMack headquarters is on the right.
