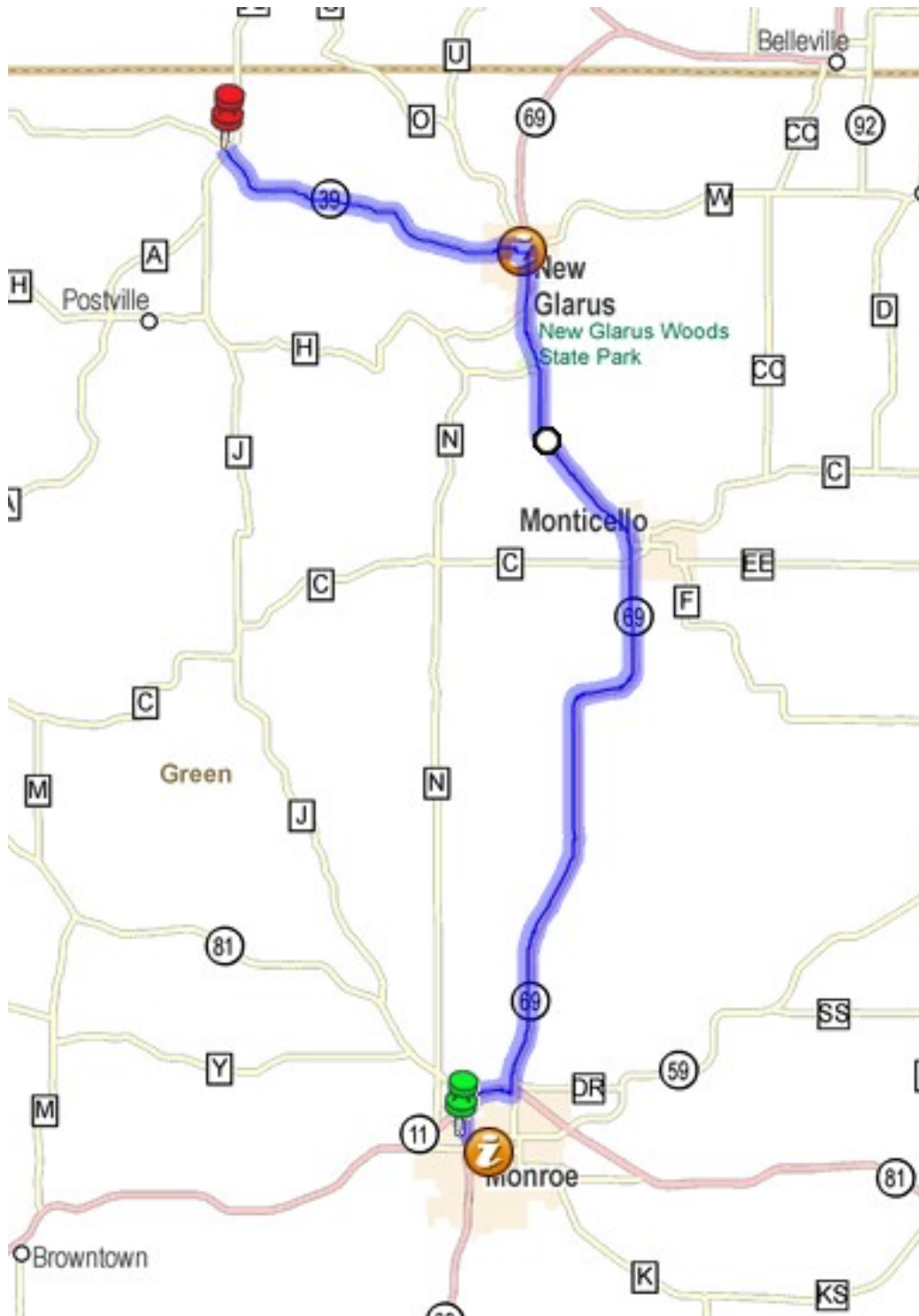

From Super 8 Hotel in Monroe, WI.

(County Road J is very twisty, so use Route 69 North to New Glarus. Should take about 30 - 35 minutes via Rt 69. Otherwise, using County Road J out of Monroe, should take about 20 -25 minutes. )

Follow signs for 69N from Hotel. Take exit for WI-69N Monticello/New Glarus. Go approx. 15 miles to New Glarus and turn Left onto WI-39. Stay left on WI-39, go about 6 miles and turn RIGHT on CR-J(north) Grounds approx. 1 mile on LEFT.
