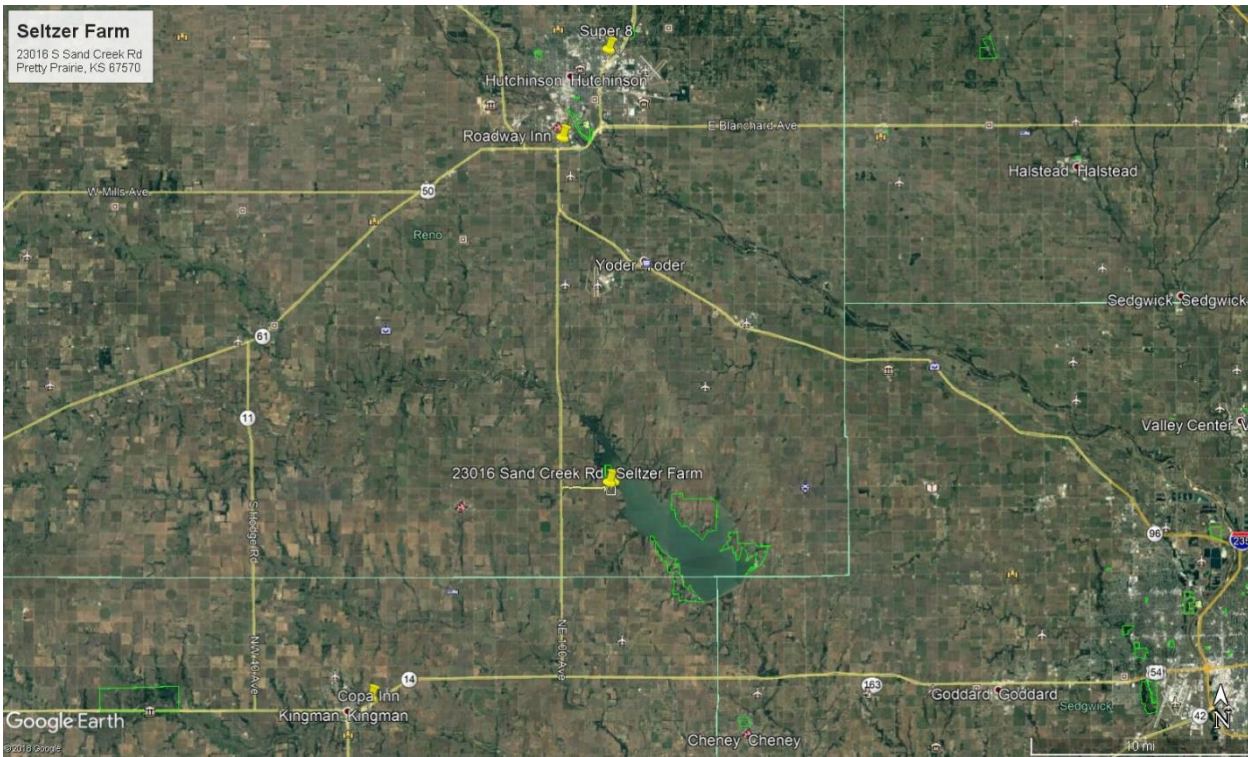
We will have pot luck lunches so bring something to throw on the table. Water and sodas will be provided.
