- 4. National Amateur Championship Topics
  - a. Report of the Nominating Committee Election of Chairpersons
    - i. 2019 MW John Meyer
    - ii. 2020 ME Change from Bill Cosgrove the Mark Brookshire was made.
    - iii. 2021 E Tim Edwards
    - iv. 2022 W TBD
  - b. Presentation of the 2019 National Amateur Championship. John Meyer
    - i. Number of points to qualify for 2019 will be 1. There was some discussion of keeping it at 2 to encourage people to attend more local trials. There was a motion to set the qualifying number at 1 which was passed by 29 and opposed by 13.
    - ii. Entry fee set at \$300 with 36 approved and 5 opposed. Discussion included subjects regarding the cost of putting on the trial and the amount of money that is donated behind the scenes to support the event. The higher fee is intended to transfer more of the cost to the participants.
    - iii. Closing dates: First closing will be November 16, 2019 and the second closing date will be November 22, 2019.
    - iv. Date and time for 2019 Delegates' Meeting will be Sunday, December 1, 2019 at 4:00pm.

### 5. New Business

- a. Presentation of proposal for 2020 NAC Bill Cosgrove.
  - i. Mark Brookshire was identified as the general chair for the 2020 NAC.
