**Club Scratch Policy**

Refunds, Scratches, No Shows, Entry fees paid for a bitch withdrawn because of coming into season or for a dog withdrawn because of an injury or illness, or for a dog which dies, shall be refunded in full by the test giving club. Prior to paying such refund, the club may require an appropriate veterinary certificate. Requests and documentation must be presented prior to the test. There will be no refunds for "no shows". Entry fees will not be refunded in the event a dog is disqualified, excused by a judge or barred from the test by action of the Field Trial Committee. No entry fee will be refunded if the test cannot be started or completed by reason of riots, civil disturbance, an act of God, public emergency, or any other cause beyond the control of the Field Trial Committee.
