Training, correcting or disciplining of dogs will not be permitted on the Field Trial Grounds. All dogs must be leashed or confined when not being trialed.

A light breakfast and lunch will be available at the trial grounds.

Extra birds not used in the trial will be for sale after Sunday's trial is over. Please bring crates if interested.

DIRECTIONS

From I-94
