Notification can also be made by phone or text (503)-539-5564 or via email [NAC@onlinenw.com](mailto:NAC@onlinenw.com). The running order may be adjusted at this time to accommodate the late entries. After notification, entries received via **phone** or **text** must be received via email to [NAC@onlinenw.com](mailto:NAC@onlinenw.com) or mail by November 28, 2019. These may not be submitted via Hunt Secretary after November 22<sup>nd</sup> 2019, 6:00p.m. PT. Payment for these entries must be received prior to the start of the trial. All other entries must be received by the original closing date of November 16<sup>th</sup>, 2019 before 6:00 p.m. PT.

Points awarded between November 5<sup>th</sup>, 2018 (inclusive) and November 22<sup>nd</sup> 2019 (inclusive), will be included in the high point calculations.
