We will be providing dinner for the judges Saturday night on the grounds. If you care to join us please bring your main course and a side dish to share. Grills will be available.

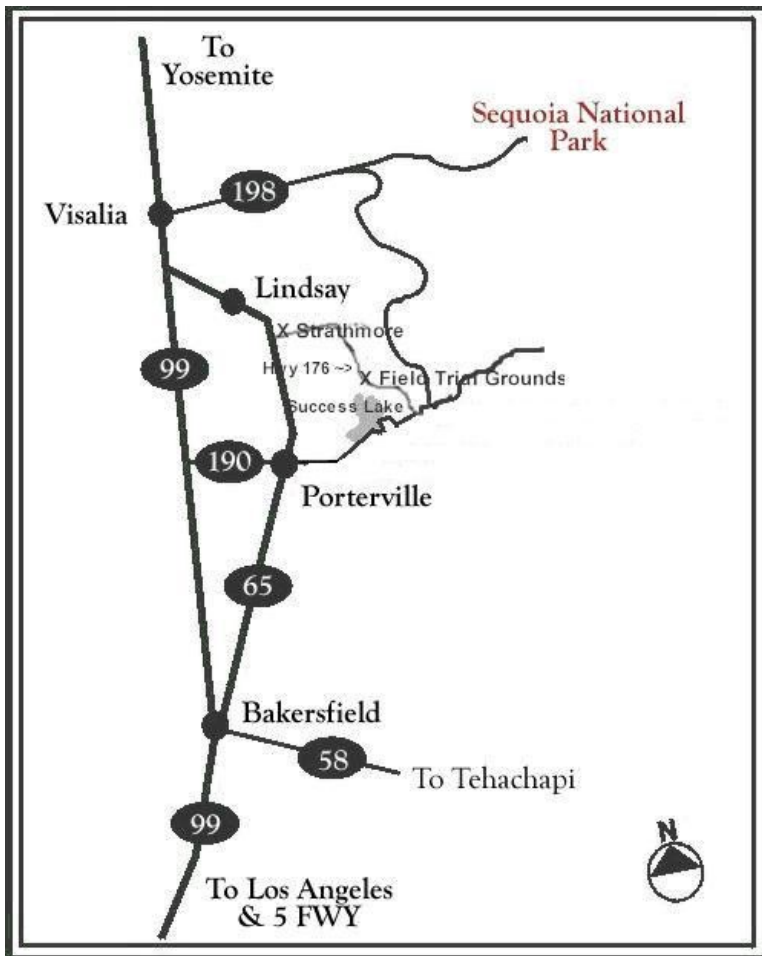

Coming from the South: Take Hwy 65 North to 190 East about 11 miles to Strathmore/Ave 176. River Island Country Club will be on your right. Turn left and continue for about 4.5 miles until you reach the Kincade Wildlife Management Area on the left.

Coming from the North: Take Hwy 64 South to Strathmore Road miles from. Turn left following the curve of the road slightly past the power plant. Look for the entrance on your right.

There will be double orange flags or signs at the entrance. Enter and follow dirt road to its end at covered picnic area. (Copy and paste link for google map)
