From Super 8 Motel, Escanaba, take Highways US2&41 & M35 North for 6.25 Miles. (You must head South on the Highway from the motel to make a U-turn onto US2 & 41 & M35 North)

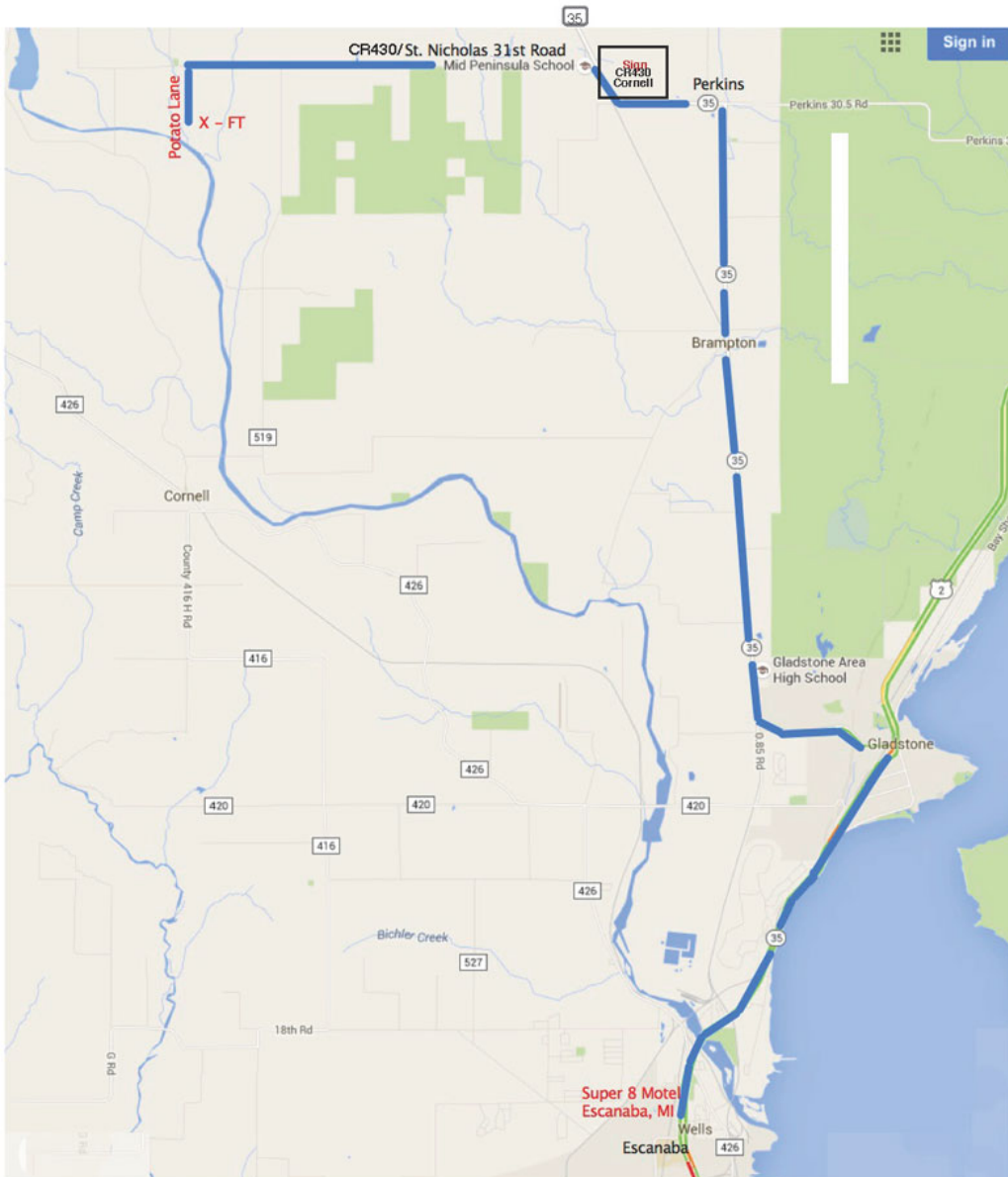
Prepare to turn left at 2nd traffic light in Gladstone onto M35 North

Continue 10 Miles on M35 North to Perkins. Left at 3-Way Stop

Stay on M35 North around bend in road approx. 2 Miles to CR 430 (St. Nicholas 31st Road). Mid Peninsula School is a short distance from the intersection of M35 & CR 430/St. Nicholas Road. You'll pass the school on your left.

Continue on CR430/St. Nicholas 31st Road for 5.5 Miles to Potato H Lane on left. FT Grounds are on the left past the cow pasture.
