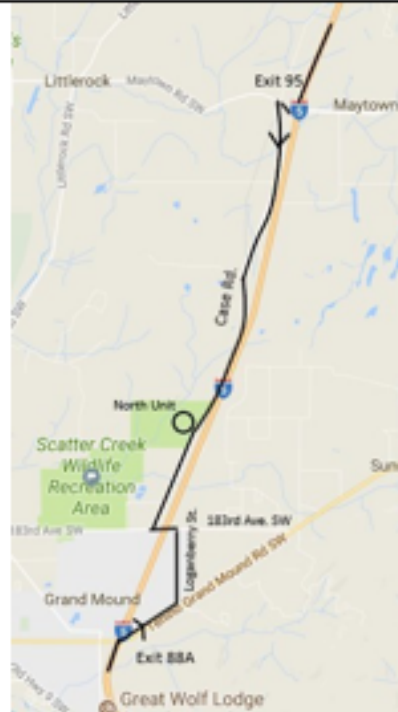

#### Directions (off I-5)

From the north: Exit 95 "SR 121 north - Little Rock, Maytown"  
Go west towards Little Rock.  
Take the first left onto Case Rd.  
Drive for 4.5 miles to the parking area for the North Unit (look for signs)

From the south: Exit 88A "US 12 West - Aberdeen, Tenino"  
Turn right and head east towards Tenino.  
Drive for 0.6 mile, turn left onto Loganberry St. SW.  
Drive for 1 mile, turn left onto 183rd Ave. SW.  
Drive for 0.3 mile, turn right onto Case Rd.
