This location is north of Marysville, Ohio on Sandusky Road. It is 11.5 miles from Marysville and should take 16 minutes to get there.

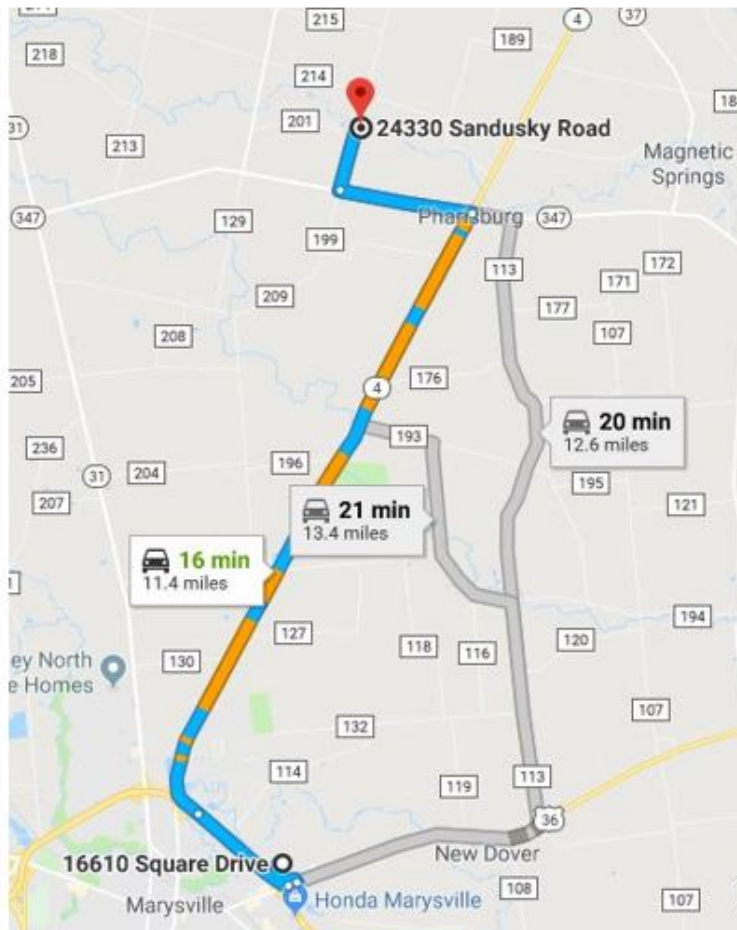
Go west on US 33 from Marysville to US 4.
