Thursday 5:30 Welcome Dinner. There is limited space so please do let us know if you are attending (\$25/roast beef with trimmings on the grounds weather permitting).

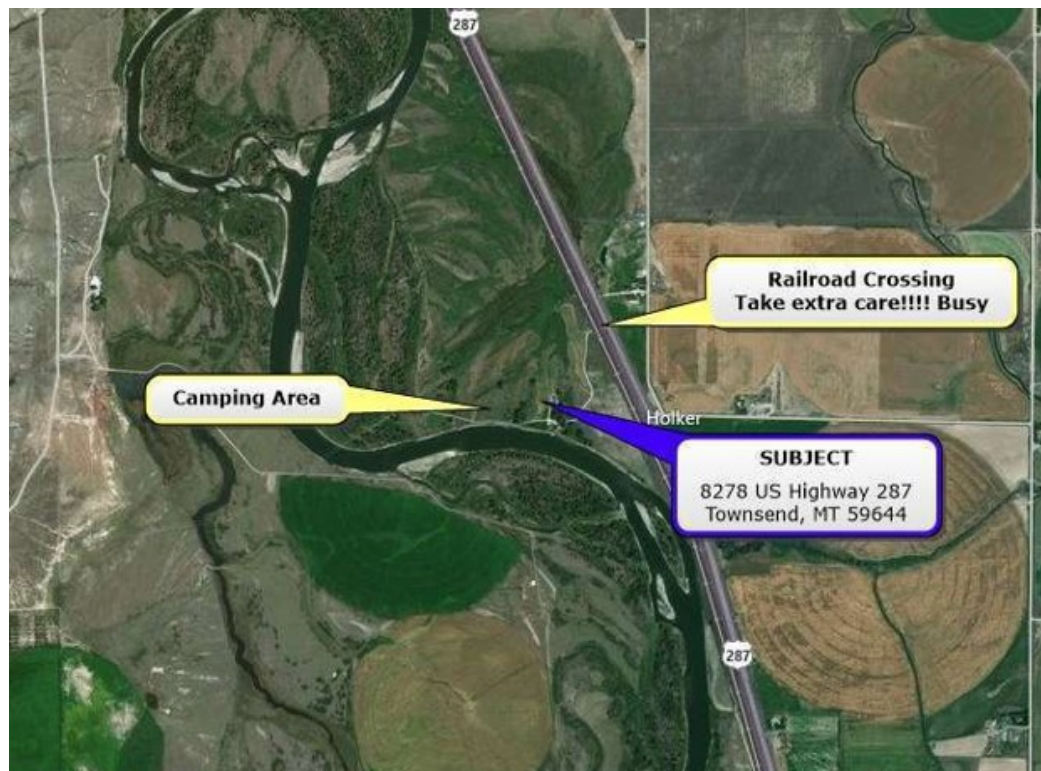
We expect courses to be approximately 30 flags out and 25 back for series work. We have exceptional opportunities for great third series courses/new each day in the woods by the river.

From either East or West Interstate 90 take Exit 274 then turn North onto Highway 287. Approximately 30 miles North, then turn left. Pay attention to mile markers and there are high transmission towers just past the turn-off. Please be extra careful crossing rail road tracks, they can be busy.

All participants, observers, guests must sign a waiver. Follow signs to check-in. If you arrive late, we will have extra waivers in the field.

Our hosts live here and have about a few hundred pet black bunnies. Make sure not to let dogs out unsupervised while in the camping area. Signs will be out directing you to the camping area.

Training will be available from 12:00 to 3:00 on Thursday for anyone wanting to try out the cover. The land owner has requested a \$15/per dog training fee which we will collect. Reserve birds ahead of time (406) 570-3093.
