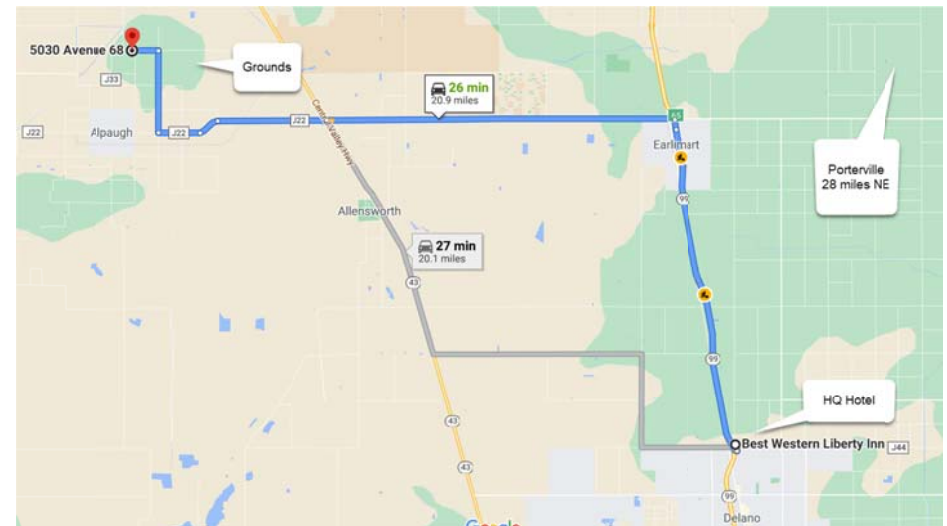
New location is approx. 40 miles SW of Porterville.
