The newest radio to hit the circuit with lots of good reviews is a Baofeng: Baofeng Model UV-5R V2. I found several listing on eBay. Several colors. Longer antennas. Waterproof cover. BE SURE the radio you purchase is capable of transmitting on VHF frequency 154.570 -- the blue dot channel. So get yourself a radio and listen to what is going on during the events
