Scratches prior to closing date will be refunded by HuntSecretary.com unless Club Scratch Policy below states otherwise.

After the closing date, all scratches will be handled based on the Club Scratch Policy specified below.

Club Scratch Policy

Refunds: Entry fees paid for a bitch withdrawn because of coming into season or for a dog withdrawn because of an injury or illness, or for a dog which dies, shall be refunded by the test giving club. Prior to paying such refund, the club may require an appropriate veterinary certificate. Requests and documentation must be presented prior to the test.

There will be no refunds for:

- a. no-shows,
- b. in event a handler or dog is disqualified or barred from the test by judges, committee, or grounds personnel,
- c. weather issues, or
- d. if test is started and cannot be completed due to circumstances beyond the control of the event committee

COVID EVENT CANCELLATION POLICY
