SCRATCHES

Scratches prior to closing date will be refunded by HuntSecretary.com.

After the closing date, all scratches will be handled based on the Club Scratch Policy specified below.

Club Scratch Policy

Refunds, scratches, no shows, Entry fees paid for a bitch withdrawn because of coming into season or for a dog withdrawn because of an injury, illness, or for a dog who becomes deceased, shall be refunded. Prior to paying such refunds, the club may require an appropriate veterinary certificate. Request and documentation must be presented prior to the trial. There will be no refunds for "no shows". Entry fees will not be refunded in the event a dog is disqualified, excused by a judge, or barred from the trial by action of the field trial committee. No entry fee will be refunded if the trial cannot be started or completed by reason of riots, civil disturbance, an act of God, public emergency or any other cause beyond the control of the Field Trial Committee. An administrative fee will be deducted from refunded entry fees if entry is withdrawn after closing. There will be a \$20 administration fee paid to the club for any refund given.
