Going north from Grass Range on Hwy 19, make a left turn onto Davis Road (this turn is 200 yards south of the 64 mile marker on Hwy 19). Proceed west on Davis Road for 2 miles and then turn south onto Satterfield Road for $\frac{3}{4}$ mile.

From Lewistown

From the Lewistown by-pass head north on Hwy 191 through the towns of Hilger and Roy for 42 miles arriving at a T intersection stop light. Turn south on Hwy 19 towards Grass Range for 2 $\frac{3}{4}$ miles. Turn west onto Davis Road for 2 miles and then turn south onto Satterfield Road for $\frac{3}{4}$ mile.
